- Mention the name of the Foundation only after expressed written authorization.
- Create a personal account on the website of the Foundation.
- Allow the Foundation to disseminate its membership to the Chart, as well as any withdrawal of the authorization to use the Charter Ambassador brand.
- Renew its membership on time, provided that it meets the requirements, together with the payment of the annual renewal fee, no later than 31st March of the current year.
